

# Introductory Course to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade

## *Course Syllabus*

# *Learning objectives*

The export of chemicals has raised grave concerns to developing countries and countries with economies in transition, as they may be faced with chemicals without adequate information about their harmful impacts and without the infrastructure to manage them in an environmentally sound manner.

This course introduces you to the Rotterdam Convention on the Prior Informed Consent Procedure for Certain Hazardous Chemicals and Pesticides in International Trade, which provides Parties with a first line of defense against hazardous chemicals.

At the end of this course, you will be able to:

1. Explain the importance of regulating international trade in certain chemicals
2. Identify the core components and mechanisms established by the Rotterdam Convention
3. Outline the synergies process undertaken by the Stockholm,
